#### Business and Information Systems

- **Information Technology** - Internet Software Services / IT Services / Software / E-Commerce / Digitalization / others
- **Financials** - Commercial Banking / Consumer Finance / Insurance / Real Estate
- **Telecommunication Services** - Telecommunication / Wireless Telecomm services
- **Consumer Discretionary** - Hotel Industry / Media / Education Services / Food Products Supply / Hypermarkets / Beverages / FMCG

#### Engineering and Construction

- **Industrial** - Energy / Oil, Gas & Consumable Fuels / Power plant / Electricals / Industrial / Commercial and Institutional Buildings / Semiconductor / Photo Voltaic (Solar) Industries / Aerospace / Airlines / Logistic / Road / Rail / Shipping/ Transportation Infra-Structure / Automobiles
- **Energy & Chemicals** - Oil, Gas & Consumable Fuels / Power plant / Chemicals / Petrochemical / Specialty Chemicals / Industrial Gases
- **Health Care** - Health Care Services / pharmaceuticals / Biotechnology / Life Sciences
- **Utilities** - Water & waste water / Electrical / Gas

## Eligibility Criteria

- The project must be completed between September 01, 2014 and September 30, 2016
- The project must be implemented in Singapore or carried out by a company based in Singapore or originated from Singapore.
- The total size of the project must meet following conditions for the categories:
  - ◆ Business and information systems: Minimum budget of S\$2mil, and 20 or more team members.
  - ◆ Engineering and Construction: Minimum budget of S\$20 mil, and 20 or more team members.
- An organization cannot submit more than 3 projects per category, but may submit project in multiple categories.
- The project has not won any PMI distinguished Project Awards.
- The project has neither been participated or Finalist nor won the SPMI POY 2014-15, SPMI POY
- 2015-2016 PMI affiliation is not necessary for nomination.

## Evaluation Process

1. The evaluation process will be governed by neutral and capable members in the industry.
2. Evaluation Committee evaluates the project nominations according to the eligibility criteria and provides the evaluation report to the Judges Panel.
3. Judges Panel selects the finalists for each category; if needed the finalists may be required to provide more detail and conduct presentations in front of the Judge Panel.
4. Judges Panel selects the winner of each category, which will be announced at the Gala SPMI POY Awards ceremony.

Three finalists will be selected under each category and all finalists will receive the Merit Award. Winner of each category will receive the SPMI-POY Award.
